1. FFN, Singapore offers an opportunity to people from different parts of the world to share lives and cultures with one another in the spirit of friendship. The personally identifiable information provided is to help FFN, Singapore to select Host or Ambassador who are representatives of their countries, community or region.
2. Participants shall not hold FFN, Singapore responsible for any injury, loss or damage which the participants may suffer as a result of participating in the outbound or inbound exchange.
3. Participants should be in good physical condition and not have medical problem that could make it difficult to participate in any activities or exchanges organize by FFN, Singapore.
4. FFN, Singapore will not sell or rent member's personally identifiable information to anyone.
5. FFN, Singapore will send personally identifiable information about members to other people when:
 - FFN, Singapore have the member's consent to share the information;
 - FFN, Singapore need to share member's information to the Ambassador or Host when members are selected for an inbound or outbound exchange respectively;
